Resolution of 28th June of Universidad de Sevilla announcing grants for the requalification of the Spanish university system for 2021-2023.

Royal Decree 289/2021 of 20th April and Order UNI/551/2021 of 26th May, which regulates the direct award of grants to public universities for the requalification of the Spanish university system, implement investment C21.I4 "Education and training of teaching and research staff of the aforementioned component 21". This is a multi-annual investment aimed at the requalification of the Spanish university system by promoting the training of its young Doctors, encouraging the mobility of its teaching and research staff for the requalification of the tenured and contracted teaching staff and attracting international talent. This investment includes the granting of subsidies to Spanish public universities for a total amount of €361.56 million for the period comprising 2021-2023. The objective is for public universities to award a minimum of 2,521 training grants in the three planned modalities by 31st December 2023.

Universidad de Sevilla plays an essential role in guaranteeing the right to education, enshrined in Article 27 of the Spanish Constitution. It also plays a key role in producing knowledge through scientific, technical, humanistic, and artistic research, and in the transfer of knowledge and innovation. In addition, it makes a decisive contribution to the training of responsible citizens and to the improvement of their professional skills.

In this context, the human capital of Universidad de Sevilla is a fundamental asset for achieving these objectives, as well as for promoting the requalification and national and international mobility of its teaching and research staff will make it possible to raise the quality of the public service they provide and thus guarantee the right to education. Indeed, the training of young PhDs, the promotion of mobility among its teaching and research staff in order to maintain their high level of qualification, and the attracting international talent within Universidad de Sevilla are fundamental objectives for catalysing the modernisation of the Spanish university system and, in short, promoting the improvement in the quality of education in Spain.

In summary, the reasons that accredit the public, social and economic interest in awarding this grant are specified in the public nature of Universidad de Sevilla and, therefore, its service to the general interest, in accordance with the provisions of Article 3 of Law 40/2015, of 1st October, regulating the Legal Regime of the Public Sector; in the inclusive nature of the grants, in accordance with objective and proportional allocation criteria; and in the ultimate purpose of the grants by contributing to guaranteeing the right to education recognised in Article 27 of the Spanish Constitution.

All of the above justifies that this investment, due both to the public nature of its beneficiaries and its purpose, responds to public, economic and social interest, being clearly



of a singular nature, so that the procedure for awarding the subsidy will be that of a direct award in accordance with Article 22.2.c) and 28 of Law 38/2003, of 17th November, the General Subsidies Law, in accordance with Article 67 of its Regulations, approved by Royal Decree 887/2006, of 21st July.

Consequently, by virtue of the provisions of both Royal Decree 289/2021 of 20th April and Order UNI/551/2021 of 26th May, in order to contribute to achieving the above objectives,

First. Purpose of the call and legal regime

1. The purpose of this resolution is to approve the rules for grants for the requalification of the Spanish university system for 2021-2023 of Universidad de Sevilla within the framework of the direct subsidy regulated in Royal Decree 289/2021, of 20th April, regulating the direct awarding of subsidies to public universities for the requalification of the Spanish university system that has been granted by means of Order UNI/551/2021, of 26th May, which grants the subsidies provided for in Royal Decree 289/2021, of 20th April, regulating the direct award of subsidies to public universities for the requalification of the Spanish university system, establishing the system for their monitoring and justification, and proceeds to call for applications.

2. These grants are multiannual in nature and are intended to enable Universidad de Sevilla to achieve aims of public, social and economic interest for improving the quality of education in respect of:

a) the training of young Doctors.

b) the requalification of the tenured or contracted university teaching staff through the promotion of teaching and research staff mobility.

c) attracting international talent.

3. The grant covered by this call for applications is governed by this Resolution and by the provisions of Royal Decree 289/2021, of 20th April and Order UNI/551/2021, of 26th May.

Regulation (EU) 2021/241 of the European Parliament and of the Council of 12th February 2021 establishing the Resilience and Recovery Mechanism, as well as other European Union provisions that can be applicable and the European Commission Recommendation (2005/251/EC) of 11/03/2005 on the European Charter for Researchers and Code of Conduct will also apply.

These grants will also be governed by the provisions of Law 6/2001 of 21st December



2001 on Universities, Legislative Decree 1/2013 of 8th January 2013, which approves the Consolidated Text of the Andalusian Law on Universities and Law 14/2011 of 1st June 2011 on Science, Technology and Innovation.

Law 38/2003 of 17th November 2003 on General Subsidies and its Regulations, approved by Royal Decree 887/2006 of 21s t July 2006, as well as the provisions of Royal Decree-Law 36/2020 of 30th December, approving urgent measures for the modernising the Public Administration and the implementation of the Recovery, Transformation and Resilience Plan, and other applicable regulations, are applicable.

Law 53/1984 of 26th December 1984, on the Incompatibilities of Staff in the Service of the Public Administration and the Royal Decree 598/1985, dated 30th April 1985, on incompatibilities of staff in the service of the State Administration, the Social Security and the dependent Entities, Bodies and Companies will also be applicable in relation to the incompatibilities of teaching and research staff of Universidad de Sevilla.

The Statute of Universidad de Sevilla, approved by Decree 324/2003 of 25th November 2003, the Regulations of the General Registry of Universidad de Sevilla (Agreement 4.1/CG 30-5-19) and the Regulations governing teaching collaboration in official courses by staff from outside Universidad de Sevilla (Agreement 8.6/CG 29-3-17) are applicable to these rules.

4. The formalisation and execution of the corresponding aid will be conditional upon notification of the decision of the competent body authorising the transfer of funding.

If, for any reason not attributable to Universidad de Sevilla, the grants referred to in this call cannot be formalised, the corresponding call will not be effective, and Universidad de Sevilla cannot be held responsible for this circumstance.

5. Universidad de Sevilla can approve and publish a new complementary call for applications for the same purpose within 18 months following the publication of the final resolution of this call, using the funds resulting from renunciations or vacancies of those grants that have not been fully or partially executed. In this case, the stays can not extend beyond 31st December 2024.

Second. Publication.

1. This call for applications will be published on the Official Electronic Bulletin Board of Universidad de Sevilla (https://www.us.es/tablon-virtual) which, in accordance with the provisions of article 4.5 of the Regulations of the Official Bulletin of Universidad de Sevilla and 11.1 of the Regulations for creating and regulating the Electronic Headquarters of Universidad de Sevilla, will have the effect of publication in the official bulletin of Universidad de Sevilla, without prejudice to the publication on the website of the Vice-Universidad Research Rectorate for of de (http://investigacion.us.es/investigacion/anuncios) of the successive acts of the grants award procedure that must be notified to the personnel applying. This publication will replace the notification, with the same effects, in accordance with the provisions of article 45.1.b) of Law 39/2015 of 1st October on the Common Administrative Procedure for Public Administrations. Therefore, the publication dates of the different acts and resolutions at the aforementioned web address will be those that determine the starting point for calculating



deadlines.

2. The link to the call for applications will also be available on the website of the Ministry of Universities.

3. The grants concession will be published in the National Subsidies Database, under the terms set out in article 20.4 of Law 38/2003, of 17th November, General Subsidies Act and in article 6 of Royal Decree 130/2019 of 8th March, which regulates the National Subsidies Database and the publicity of subsidies and other public aid.

Third. Modalities and distribution of the number of grants.

1. Grants financed under this call for proposals will comprise the following types of grants:

Modality A. Margarita Salas Grants for the training of young Doctors.

The purpose of these grants is the training of young Doctors by means of training stays at a Spanish public university, Spanish Public Research Bodies or at foreign universities and research centres. These grants can have a two-years duration, and in exceptional circumstances, a three-year duration. They can only be applied for, and undertaken, on a continuous basis. If the last year is spent at Universidad de Sevilla, beneficiaries may carry out teaching collaborations of up to 60 hours, which must be authorised by department to which they are assigned. For these purposes, section 4.6 of the regulations governing teaching collaboration in official courses by staff from outside Universidad de Sevilla will be considered applicable. Three-year stays must begin on 1st January 2022.

Modality B. Grants for the requalification of tenured or contracted university teaching staff.

The purpose of these grants is to requalify teaching staff at Universidad de Sevilla, whether tenured or contracted, through training stays at a national or foreign public university or a research centre other than Universidad de Sevilla. These grants will have a one-year duration. They can only be applied for, and undertaken in a single one-year period, in two six-month periods, with a maximum gap of 12 months between the two periods. They must end on or before 31st December 2024. Assistant Lecturers will maintain the reservation of a place at the university where they are contracted, without loss of seniority, for the duration of the training stay financed by these grants. The lecturer will be granted a one-year septennial leave of absence under the terms established in the Regulations on septennial leave of absence in the framework of the call for grants for the requalification of the Spanish University System (Agreement 6.3/CG 24-6-2021).

Modality C. María Zambrano Grants for the attracting international talent.

The purpose of these grants is to attract to Universidad de Sevilla teaching and research staff with accumulated post-doctoral experience in foreign universities or research centres. These grants are aimed at teaching and research staff, be they Spanish or foreign nationals, with an accumulated post-doctoral career of no less than twenty-four months in universities



or research centres located outside Spain, other than the one in which their doctoral thesis was defended. The grants' duration can be of one or two years. They can only be applied for, and undertaken, on a continuous basis. Beneficiaries can carry out teaching collaborations of up to 60 hours, which must be authorised by department to which they are assigned. For these purposes, section 4.6 of the Regulations on Teaching Collaboration in official teaching by staff from outside Universidad de Sevilla will be considered applicable. At the end of the stay, Universidad de Sevilla, through its Research Commission, or through an external evaluation process, will evaluate the scientific impact and milestones achieved by each beneficiary. The result of this evaluation can be taken into account as a merit for incorporating the beneficiaries into the Talent Recruitment Plan of Universidad de Sevilla.

For the three modalities, the stays must begin within a maximum period of three months from the publication of the final award decision, unless one of the justified reasons listed in point 4 of the third base of this call is given, and the request for delay is authorised, and can not end after 31st December 2024.

2. 55% of the amount of the grants awarded to Universidad de Sevilla within the framework of the requalification of the Spanish university system is earmarked for modality A, Margarita Salas for the training of young Doctors; 25% of the amount is dedicated to modality B, Grants for the requalification of a tenured or contracted university teaching staff, and 20% of the amount is earmarked for modality C, María Zambrano Grants for attracting international talent, in accordance with the distribution criteria established in Annex I of this Resolution.

Should, once the grants have been awarded, between 50% and 55% of the amount earmarked for Modality A remain unallocated, this amount will be credited to Modalities B and C at a rate of 60% and 40%, respectively.

In the same way, if, once the grants have been awarded, any remainder initially earmarked for modality B remains unallocated, it will be used to increase the amount earmarked for modality C. Similarly, if, once the grant initially allocated to modality C has been granted, any remainder remains unallocated, this will increase the amount allocated to modality B.

If there are any remaining amounts in Modalities B and C, both amounts will be credited to Modality A.

In the grant corresponding to Modality B, retraining tenured or contracted university teaching staff, the amount allocated will be divided in 50/50 between the permanent and temporary teaching staff included in the present call for applications. If any amounts remain unallocated in either of these groups, they will be given to the other group. Within the permanent teaching and research staff, half of the amount will be divided between the group of tenured university lecturers and the group of contracted doctoral lecturers. The amounts not awarded will be passed on to the other group.

3. 2% of the amount earmarked for each of the grant modalities is reserved for persons with a recognised disability equal to, or greater than, 33%. When these persons exceed the established minimum score, they will be entitled to the concession of a grant not exceeding the 2% limit, even if they have a lower score than the rest of the candidates. Granting aid in each of the modalities in this reserve quota will be made in accordance with the standardised score obtained by each of the candidates. The unawarded amounts reserved for people with disabilities will be accumulated with the rest of the grants in each of the modalities of the reserve. A reserve list will be drawn up for this category in each of the grant modalities



comprising those applicants who, having attained the minimum score, have not obtained a grant. These reserves will be taken into consideration in the definitive award decision for cases of renunciation or abandonment that occur within the scope of this reserve.

4. Applicants can interrupt their grant or delay their incorporation for duly justified reasons of force majeure. The interrupted period is irrecoverable, and during this period, the grant will have no economic-administrative effects. Only in the event that the cause is due to the health emergency situation caused by COVID-19, situations of temporary disability, accident, risk during pregnancy, maternity, paternity, adoption or fostering, can the interrupted time be recovered, but under no circumstances will postponing the stay's termination the date entail an increase in the grant received by the beneficiary. A delay in incorporation due to visa processing can be justifiably requested.

In all cases the interested party must previously submit an application, which Universidad de Sevilla must authorise. Under no circumstances can the end date of the stay be later than 31st December 2024, nor can it exceed 30% of the total period of the stay.

Apart from the cases considered in this section, no modifications will be authorised in implementing the stays that have been granted.

Fourth. Amount of grant and details of the item financed.

1. The budget allocation for the Universidad de Sevilla in this call for applications for the financial years 2021, 2022 and 2023 in the General State Budget is €16,801,356.

The amounts of the grant that are granted to Universidad de Sevilla will be charged to the following budgetary applications of the Expenditure Budget in the following manner:

2021-1888923206-541-649.00; Amount: €5,600,452.

2022-1888923206-541-649.00; Amount: €5,600,452.

2023-1888923206-541-649.00; Amount: €5,600,452.

2. The amount of grant to the beneficiaries of each modality will be as follows:

a) Margarita Salas grants. Beneficiaries will receive a mobility grant of \notin 3,500 gross/month for stays abroad and \notin 2,800 gross/month for stays in Spain.

In the case of complete stays at Universidad de Sevilla, a contract giving access to SECTI will be drawn up, with a total contract cost, including the employer's social security contribution, of \in 33,600/year. In the same terms, a contract giving access to SECTI will be drawn up during the year of return, provided that this takes place at Universidad de Sevilla.

b) **Grant for retraining university teaching staff**. The grant will be equivalent to the gross annual salary (basic salary plus current allowances) of the beneficiary at the date the grant is granted, plus an additional mobility bonus of twenty per cent of that gross salary.

c) María Zambrano Grants. A Distinguished Researcher contract will be made for the duration of the stay granted, the total cost of the contract, including the company's social security contributions, will be \notin 48,000/year.

This grant will not be updated by annual salary increases approved in general, nor by the recognition of new salaries.

3. In all cases, the beneficiary will also receive a one-off payment of \notin 3,500 as a relocation allowance, which can be used to pay for the compulsory insurance described in point 4 of Part



4, which will be paid upon acceptance of the grant by the beneficiary.

4. The beneficiaries of these grants must take out insurance at their own expense. As well as any other insurance required by the host centre, this insurance must cover health care, repatriation, civil liability, and damages in the place of their stay. As far as possible, Universidad de Sevilla will facilitate the contracting of the insurance policies.

5. The grant granted will be incompatible with any other aid, income or resources obtained for the same purpose from any Administration or public or private bodies, national organisations, the European Union or from international organisations and, in general, it will be incompatible with the receipt of any salaried sums, when the activity undertaken out can affect the fulfilment of the purpose of the grant or its research purpose or when it takes place over the same period.

6. When the beneficiaries of the grants provided for in Modality A, Margarita Salas Grants for training young Doctors have to be registered with the Social Security, both during their stays in Spain and abroad, the amount of the social security contributions will be deducted from the amount of the grants, and Universidad de Sevilla or the beneficiary, under the legal provisions, will be responsible for making this registration.

Fifth. Requirements for candidates.

1. Applicants must meet the following requirements by the closing date for submitting applications:

a) In Modality A, Margarita Salas Grants the training young Doctors:

i. A maximum of two years must have elapsed between the date on which the doctoral degree was obtained and the closing date for submitting applications.

However, these two years will be extended if any of the following situations apply:

1. Birth of a child, or care of a child in cases of adoption or in cases of foster care for the purpose of adoption or permanent foster care, provided that the date of birth or, where applicable, of the court or administrative decision has occurred between the date on which the doctoral degree was obtained and the closing date for submitting applications. An extension of one year will be applied per child.

2. Temporary incapacity during pregnancy for reasons related to the pregnancy, suspension of the contract due to risk during pregnancy or due to risk during breastfeeding of a child under the age of nine months. An extension equal to the period justified will be applied.

3. Temporary incapacity for reasons other than those in the previous point for a period of at least three consecutive months. An extension equal to the period justified will be applied.

4. Leave of absence for childcare, care of a family member, gender violence and terrorist violence, for a minimum period of three months. An extension equal to the justified period will be applied.

5.° Reduction in working hours for legal guardianship, for the direct care of a family member, or to care for a minor affected by a serious illness, for a minimum period of three months, calculated in full working days. An







extension equal to the period justified will be applied.

6. Care for dependent persons, in accordance with the provisions of Law 39/2006, of 14th December, on the Promotion of Personal Autonomy and Care for Dependent Persons, for a minimum period of three months. An extension equal to the justified period will be applied. These periods will be indicated and duly accredited at the time of submitting the application. Provided that the periods justified do not coincide in the same period of time, applying more than one of the situations foreseen in this section will be compatible, and different periods can be accumulated. The extension to be applied will be calculating by rounding the period justified up to full months or, if several periods apply, the sum of the periods justified. For these purposes, the period justified for the birth or care of a child will be one year per child, counting from the date of birth or the from date of the court or administrative decision.

7. An extension of two additional years will be applied for people with a recognised disability equal to, or greater than, 33%.

ii. Applicants must apply to join a public university or research centre other than the one where they undertook their pre-doctoral training and obtained their doctorate.

iii. Must have obtained a doctoral degree from Universidad de Sevilla, from private universities or Spanish nationals who have obtained their doctorate from foreign universities or research centres.

iv. If applicants who have obtained their doctoral degree from Universidad de Sevilla apply for training stay grants in universities or research centres located abroad, or for training stays in Spanish public research centres, the last year of the grant must be undertaken in a Spanish public university of their choice. This choice includes Universidad de Sevilla.

v. In the case of those who have obtained a doctoral degree from private universities, or in the case of Spanish nationals who have obtained a doctoral degree from foreign universities or research centres, it is an obligatory requirement that the post-doctoral stay be undertaken entirely at Universidad de Sevilla, or that they spend at least the last year of the grant at Universidad de Sevilla.

vi. Applicants must not have been dismissed, by means of disciplinary proceedings, from the service of any of the Public Administrations, nor must the not have been disqualified from undertaking public functions. Foreign nationals must not have been disqualified, be in an equivalent situation, or have been subject to a disciplinary sanction that prevents access to public employment in their State.

b) In Modality B Grants for the requalification of tenured or contracted university teaching staff, the following conditions must be fulfilled:

i. Applicants must hold the position of *Profesor Titular de Universidad de Sevilla*, *Profesor Contratado*, *Doctor* or *Profesor Ayudante Doctor*.

ii. Applicants must apply to join a university or public research centre other than Universidad de Sevilla.

iii. Full university lecturers and doctoral contract lecturers will have no more than ten years' service in these positions.

iv. Applicants must not have been dismissed, by means of disciplinary proceedings, from the service of any of the Public Administrations, nor must the

not have been disqualified from undertaking public functions. Foreign nationals must not have been disqualified, be in an equivalent situation, or have been subject to a disciplinary sanction that prevents access to public employment in their State.

c) In modality C María Zambrano Grants for attracting international talent :

i. At the time of submitting the application, applicants must be carrying out research projects and/or teaching at universities or centres outside Spain.

ii. Applicants must be teaching and research staff, hold Spanish nationality or be a foreign national and have an accumulated post-doctoral career of no less than twenty-four (24) months in Spanish universities or research centres or centres located outside Spain, other than that where they defended their doctoral thesis.

iii. The stays that are the object of the grants are undertaken at Universidad de Sevilla.

iv. Applicants must be able to justify the impact that their incorporation will have on the requalification of the host team at Universidad de Sevilla.

v. Applicants must not have been dismissed, by means of disciplinary proceedings, from the service of any of the Public Administrations, nor must the not have been disqualified from undertaking public functions. Foreign nationals must not have been disqualified, be in an equivalent situation, or have been subject to a disciplinary sanction that prevents access to public employment in their State.

Sixth: Competent bodies.

1. With regard to Modality A, Margarita Salas Grants for the training of young Doctors, Universidad de Sevilla is responsible for receiving and managing applications from young Doctors who have obtained their doctoral degree at this University, as well as applications submitted by candidates who have obtained their doctoral degree at private universities or candidates holding Spanish nationality who have obtained their doctoral degree at a foreign university or research centre, when the centre chosen to carry out the post-doctoral stay or the one they request to join in the final year of the grant is Universidad de Sevilla.

With regard to Modality B Grants for the requalification of tenured teaching staff or contracted university teaching staff, Universidad de Sevilla is responsible for receiving and managing applications from its own teaching and research staff included in the scope of this call for applications.

Applications relating to Modality C, María Zambrano Grants for international talent attraction will be received and managed by Universidad de Sevilla, when it is the centre for which admission is requested.

2. The competent body for the instructing of the procedure for awarding the grants covered by this call for applications will be the Vice-Rectorate for Research of Universidad de Sevilla. The responsible party for issuing the appropriate resolutions for the award of grants will be the Rector of Universidad de Sevilla.

3. The competent bodies for assessing and selecting applications will be the Evaluation Committees referred to in the following Rules of this Resolution.



Seventh. Evaluation Committees.

1. The evaluation of the applications corresponding to the grants called will be undertaken in the five branches of knowledge by the Evaluation Committees set out in Annex II of this Resolution.

2. The members of the Evaluation Committees appointed by Universidad de Sevilla must submit a declaration of absence of conflict of interest in accordance with Annex III.

3. Evaluation will be undertaken in pairs, the final evaluation being the arithmetic mean of these evaluations. In the event of a major discrepancy being detected by the Coordinator of each Committee, a third evaluation will be carried out, and the Evaluation Committee will take the appropriate decisions regarding the final evaluation.

Eighth. Application deadline.

1. The period for submitting applications for the different types of grants will start at 00:00 hours on 29th June and end at 15:00 hours (Spanish peninsular time) on 20th July 2021.

2. Applications will be submitted via the application manager (https://investigacion.us.es/sisius/investigador/recualificacion) according to the standard application form available at: <u>https://investigacion.us.es/convocatorias/ver/1415</u>).

The application form must be accompanied by the documentation in digital format and in pdf format, through the application manager, supporting the requirements and merits indicated in Annex IV (file size is limited to a 4MB maximum).

3. Applicants with a recognised degree of disability equal to or greater than 33% wishing to participate in any of the grant modalities of this call for applications must indicate this expressly in the corresponding section of the application. They must attach a valid certificate, issued by the competent body, accrediting their status as a disabled person and their recognised degree of disability. This disability must be officially recognised at the end of the deadline for submitting applications.

4. Once the application has been registered in the application manager and all the required documents have been attached, the applicant must complete the process and generate the document certifying that the application has been submitted.

Exceptionally, residents outside Spain who cannot submit their application using the General Registry of Universidad de Sevilla because they do not have the necessary digital certificate to perform the procedure, can send their digitally Signature application by email to the address registro-recualificacion@us.es, authorising the Vice-Rector for Research to submit it on their behalf through the Registry. To do so, they must use the form that will be published



for this purpose on the website of the Vice-Rector's Office for Research (http://investigacion.us.es/investigacion/anuncios). The email must be sent before 16^{th} July 2021 at 23:59 hours (GMT+1).

If the candidate submits several applications within the application period, the last application submitted, and its associated documentation only will be considered.

5. The documents and information included in the application will be deemed to be attached to the application.

6. Participation in this call implies the acceptance that the internal or external management, evaluation, and verification bodies can use the data provided for the purposes of the process regulated in this call.

Submitting an application for any of the grant modalities of the call for proposals implies acceptance and conformity with its content.

7. This call will be treated as urgent, which will affect the administrative deadlines.

Ninth. Grants.

1. Once the applications submitted have been reviewed, the provisional list of applicants admitted and excluded will be published on the website of the Vice-Rectorate for Research of Universidad de Sevilla (http://investigacion.us.es/investigacion/anuncios).

2. Applicants who do not meet the requirements or who do not submit the required documents will have a five-day period in which to rectify this lack or to attach the necessary documents. If they fail to do so, they will be considered as having withdrawn their application, subject to a prior decision. Under no circumstances can applications submitted be reformulated during this period.

3. Once the allegations and documentation submitted have been reviewed, the definitive list of applicants admitted to, or excluded from, processing will be published on the website of the Vice-Rectorate for Research of Universidad de Sevilla (http://investigacion.us.es/investigacion/anuncios). Applicants admitted will be evaluated following the procedure established in Rule Ten.

Tenth. Procedure for evaluating applications and selecting beneficiaries.

1. Grants will be conceded on a competitive basis, according to the principles of publicity, transparency, objectivity, equality, and non-discrimination, and the according to principles of effectiveness in meeting the objectives set and of efficiency in the allocation and use of public resources.

2. The evaluations will be undertaken by the Evaluation Committees in accordance with the provisions of Rule Seven.

3. Those acts that must be notified to applicants will be published on the website of the Vice-Rectorate for Research of Universidad de Sevilla

4. The selection process will comprise a single phase in which the candidate will be selected after evaluating the applications submitted and issuing the corresponding report-proposal. Applications will be marked on a range of 0 to 100 points on the basis of the following evaluation criteria:

(a) Candidate's CV, up to 50 points

b) Scientific and technical background of the recipient group, up to 30 points.

(c) Supporting memorandum, up to 20 points.

The minimum pass score required will be 80 points.

Additional and specific Evaluation criteria are set out in Annex V.

5. Once the applications have been assessed, a comparison of the applications will be made on the basis of the assessment report, in order to establish a ranking among them. This will follow the procedure set out in Annex I, establishing a joint list of all the applications and then proceed to the provisional award of grants in the three types of grants.

6. The provisional award will be issued and published on the website of the Office of the Vice-Rector for Research (<u>http://investigacion.us.es/investigacion/anuncios</u>). There will be a five-day period starting on the day after its publication in which candidates will be able to present appeals. The published proposal will include the beneficiaries and the members of the reserve list with all of the applicants who have passed the minimum score established for each of the grant types.

This provisional award will be deemed to be accepted if the provisional beneficiaries do not raise objections after the grant proposal has been made.

Eleventh. Final award decision.

1. Once the allegations presented against the provisional award decision have been addressed, the final list of grants awarded will be submitted to the Rector of Universidad de Sevilla, who will issue the final decision. This which will be published on the Official Electronic Bulletin Board of Universidad de Sevilla (https://www.us.es/tablon-virtual) in accordance with the provisions of articles 4.5 of the Regulations of the Official Bulletin Board of Universidad de Sevilla and 11.1 of the Regulations for creating and regulating the Electronic Headquarters of Universidad de Sevilla. It will also be published for information purposes on the website of the Vice-Rectorate for Research (http://investigacion.us.es/investigacion/anuncios).

This award decision will list the beneficiaries and those on the reserve lists in each of the branches of knowledge of the three modalities.

2. This Resolution, which must be duly reasoned with reference to this call for applications, must contain at least the names of the beneficiaries in each of the grant modalities, the amount of granted, the deadline for acceptance, where appropriate, of the grant, and a reserve list in case of renunciation or abandonment, including a specific reserve list for reserves in the disability category.

3. The decision of the procedure will be issued and published before 1st December 2021 and







will be final.

Twelfth. Appointing substitutes

1. In the event of renunciation or abandonment of a grant by its beneficiary, the grant can be filled by the substitute on the corresponding reserve list according to the prioritisation established by the Evaluation Committee and described in Annex I.

2. Stays allocated to substitute candidates cannot be undertaken or extended beyond 31^{st} December 2024.

3. If the renunciation or abandonment occurs within the disability reserve quota, the person, if any, who replaces him/her will be selected from the reserve list established for each of the grant modalities for this turn.

Thirteenth. Obligations of the beneficiaries.

Beneficiaries of the grant will have the following obligations:

- a) To take out an insurance policy or policies covering health care, repatriation, civil liability, and damages in the place of the stay, as well as any other insurance required by the host organisation. The cost of such insurance will be borne exclusively by the applicant, who cannot apply for funding additional to that granted for this purpose.
- b) To register with Social Security when legally required to do so.
- c) To undertake the planned stay in accordance with the terms established in the grant decision and in the application. If at least 50% of the stay is not carried out, the beneficiary must return the totality of the grant received with the corresponding legal interest.
- d) to present the scientific-technical report provided for in the following rules and justify the implementation of the action financed and the conditions, if any, imposed in the award decision.
- e) To provide Universidad de Sevilla with all of the documentation and information it needs to fulfil its own obligation to justify the subsidy received for the financing of the grants awarded for the requalification of the Spanish university system by this University.
- f) To submit to the verification actions to be undertaken by Universidad de Sevilla, as well as to any other verification and financial control actions that can be undertaken by other competent control bodies and other verification and control bodies.
- g) To adopt, according to the rules approved by this University, those measures to give adequate publicity to the public nature of the funding in the media used for disseminating the funded action.
- h) To communicate to the Vice-Rectorate for Research of Universidad de Sevilla any eventuality that alters the conditions that determined the concession of the grant or that hinder the undertaking of the financed action.
- i) In the actions carried out, in whole or in part, through these grants, which involve dissemination, whether in print or by any other means, the institutional logo of the "Ministry of Universities" must be visibly incorporated in order to identify the public origin of the grants, in accordance with the provisions of Royal Decree 1465/1999, of 17th



September, which establishes the criteria for institutional image and regulates the documentary production and printed material of the General State Administration, as well as the provisions of the Resolution of 10th July 2018, of the Secretary of State for Public Function, which updates the Institutional Image Manual. Additionally, the publicity and dissemination obligations established by European Union regulations must be complied with, by means of the Union emblem, and an appropriate funding statement indicating "funded by the European Union - NextGenerationEU", the publicity and dissemination obligations established by European Union and Spanish regulations in relation to the use of funds linked to the European Recovery Instrument must be complied with, in particular when promoting the actions and results, providing consistent, effective and proportionate information aimed at multiple audiences, including the media and the public.

- j) Follow Universidad de Sevilla rules for signing scientific publications.
- k) To have the administrative authorisations that are legally required to be able to carry out the stay that is the object of the grants, both in Spain and in the different countries where the stays are to be carried out.
- 1) Any other obligations imposed on beneficiaries in the applicable Community, State or Autonomous Community legislation, in the regulatory rules, in this call for applications and in the final award decision.

Fourteenth. Grant payment and justification.

1. Payments will deposited into the current accounts specified by the beneficiaries following the final decision of the procedure on the standard form established for this purpose.

Payment of the first monthly payment of the grant will be conditional upon the beneficiary presenting, within a maximum period of 15 days from the time of effective incorporation, the document, Signature by the person in charge of the centre, accrediting his/he r incorporation into the destination centre. Failure to present proof of incorporation can result in the loss of the right to the grant and in the reimbursement of the amount received for transfer expenses with the corresponding interest.

2. Within a maximum period of two months after the end of their activity, grant recipients must present a scientific-technical report indicating the activities undertaken and the results obtained, as well as documentation accrediting the trips and stays carried out. The scientific-technical report must be completed in accordance with the models and instructions for justification issued in this respect.

3. In addition, Universidad de Sevilla may, by means of a sampling procedure, request from the beneficiaries any other supporting documentation relating to these grants, without prejudice to the submission to the relevant verification and control.

4. Failure to present the corresponding documentation for justifying the aid will entail repayment of the non-justified amounts received with the corresponding legal interest and, where appropriate, the loss of the right to the payment of the amounts pending.

5. In cases where conduct could constitute an administrative or disciplinary offence, the corresponding procedure will be initiated in accordance with the regulations applicable.

Fifteenth. Loss of entitlement to grant and reimbursement.

1. The cases established in Articles 37, 41, 42 and 43 of Law 38/2003, of 17th November,





General Law on Subsidies, and in Chapter II of Title III of its Regulations, approved by Royal Decree 887/2006, of 21st July, without prejudice to the provisions of Article 7, of Law 11/2020, of 30th December, will constitute grounds for loss of entitlement to the grant and reimbursement.

2. In particular, the following will be specific grounds for repayment of aid:

a) When changes occur during the execution of the financed activity that prevents such execution, as indicated in the award decision and in these regulatory rules.

b) When the successful candidate expressly renounces the contract.

(c) Where changes occur in the execution of the activity with respect to the conditions initially assessed which can lead to a change in the characteristics and conditions that led to said assessment.

d) When at least 50% of the total planned stay is not carried out.

Sixteenth. Processing personal data.

1. The data of the participating staff collected as a result of their participation in this call will be processed in accordance with the provisions of the current regulations on Personal Data Protection (EU Regulation 2016/679, of 27th and Organic Law 3/2018, of 5th December, on Personal Data Protection and guarantee of digital rights). The holder of the data is also informed of the right to exercise, at any time, his/he r right to access, rectify and cancel.

2. Submitting an application under any of the grant modalities of this call entails the candidate's accepting the processing of personal data that are in, or can be derived from, the application. Such processing is solely and exclusively for the purposes of this call.

3. In compliance with the provisions of the previous section, submitting an application, in any of the modalities of this call, will require submitting the document contained in Annex VI Signature by the applicant.

Seventeenth. Gender-neutral declaration

Any reference in these Rules and Call for Proposals to persons or groups in the masculine gender will be understood as unmarked grammatical gender, including reference to men and women.

Eighteenth. Delegation of powers to sign.

The Vice-Rector for Research and the Vice-Rector for Teaching and Research Staff are hereby delegated to sign the various documents, annexes, and resolutions, including the final award resolution, arising from this call for applications. The resolutions and acts Signature will expressly state that they are undertaken by virtue of this delegation.



Nineteenth. Executing the call

The Vice-Rector for Research is authorised to issue as many resolutions and instructions as necessary for the implementing this call and, in particular, to appoint replacements for the members of the Evaluation Committees when vacancies arise.

The interested parties can lodge a contentious-administrative appeal against this Resolution, which exhausts administrative channels before the Contentious-Administrative Court of Seville, within a period of two months from the day following the date of publication of this Resolution, in accordance with the provisions of articles 4.1, 8.3, 14 and 46.1 of Law 29/98, of 13th July, regulating the Contentious-Administrative Jurisdiction or, alternatively, Appeal for Reconsideration before this Resolution, in accordance with articles 112.1, 123.1 and 124.1 of Law 39/2015, of 1st October, on the Common Administrative Procedure of Public Administrations.

ANNEX I. Distributing the number of grants and award criteria

Applications with more than 80 points will be selected. Applications scoring less than 80 points will not be considered in the process described below for the award of grants, nor for the drawing up of the lists of substitute candidates.

The values of the evaluations obtained by those applications scoring at least 80 points will be normalised, taking as a reference the arithmetic mean value in each branch of knowledge of the proposals that meet this requirement.

- a. Applications will be ranked according to a standardised overall score.
- b. In the event of a tie, applications will be prioritised in the following order:
 - Normalised CV score
 - Normalised scientific-technical background score recipient group
 - Normalised Score supporting memorandum
 - Female applicant
 - Youngest applicant
 - Random draw

Once the applications have been sorted and their scores have been standardised, they will be allocated according to the following procedure (in each step, the grants awarded in the previous steps are counted for the quota to which they refer):

- 1. In accordance with Rule Three 3, 2% of the amount earmarked for each of the grant modalities is reserved for people with a recognised disability equal to, or greater than, 33%. When the number of people in this category exceeds the established minimum score, they will be entitled to receive a grant up to, but not exceeding, the 2% limit even if they have a lower score than the rest of the candidates. Awarding grants in each of the modalities in this reserve quota will be undertaken in accordance with the standardised score obtained by each of the candidates. A list of substitute candidates will be created.
- 2. Modality A Margarita Salas:
- a. The minimum number of grants to be awarded in each of the five branches of knowledge will be selected in the order of standardised scoring, budget and the established quotas allowing. The minimum number of grants to be awarded in each branch will be the result of the following calculation:

The integer resulting from the elimination of decimal places will be taken unless it is less than one. In this case, one will be taken.





- b. An additional number of applications will be selected up to 55% of the total amount of the grant received, if possible.
- c. In the above awards, for three-year applications, an initial two years will be awarded. If 55% of the total amount of the grant received is not reached, the third year of stay will be awarded, in order of score, until the previous quotas are reached.
- d. Should, once the grants have been awarded, between 50% and 55% of the amount earmarked for Modality A remain unallocated, this amount will be credited in a percentage of 60% and 40% to Modalities B and C, respectively.
- 3. Modality B -Reclassification of university or contract teaching staff
- a. The minimum number of grants to be awarded for each of the five branches of knowledge for this modality will be selected in order of standardised score, provided that the budget and the established quotas allow it. The minimum number of grants to be awarded in each branch will be the result of the following calculation:

The integer resulting from eliminating decimal places will be taken unless it is less than one. In this case, one will be taken.

- b. An additional number of applications will be selected until 25% of the total amount of the grant received is reached, if possible. In the grant corresponding to Modality B grant for the retraining of tenured or contracted university teaching staff, the amount allocated will be divided in 50/50 between the permanent teaching staff of the University and temporary teaching staff among those included in the present call. If any amounts remain unallocated in one of these groups, they will be credited to the other. Within the permanent teaching and research staff, half of the amount will be divided between the group of tenured university lecturers and the group of contracted doctoral lecturers. The amounts and contracts that are not awarded will pass to the other group.
- 4. Modality C María Zambrano
- a. The minimum number of grants to be awarded for each of the 5 branches of knowledge for this modality will be selected in order of standardised score, provided that the budget and the established quotas allow it. The minimum number of grants to be awarded in each branch will be the result of the following calculation:

The integer resulting from the elimination of decimal places will be taken unless it is less than one. In this case, one will be taken.

- b. An additional number of applications will be selected up to 20% of the total amount of the grant received, if possible.
- Should, once the grants have been awarded, any remainder initially earmarked for modality B remain unallocated, it will be added to the amount earmarked for modality C. Similarly, if, once the grant initially allocated to modality C has been granted, any remainder remains unallocated, it will be added to the amount allocated to modality B. Should there be any remainders in Modalities B and C, both amounts will be credited to Modality A.
- 6. A list of substitutes will be drawn up for each modality in order of standardised score.
- 7. In the event of renunciation, the grant will be allocated to the next applicant resulting from the re-applying the above criteria, as set out in Rule Twelve.

The Assessment Committees will comply with the principle of gender balance. They will be made up of at least three professors or research staff of recognised prestige. In addition, the majority of the members will be external to Universidad de Sevilla.
