 45 numbers. If the accession numbers have not yet been obtained at the time of submission, please state  
 46 that they will be provided during review. They must be provided prior to publication.

47 Interventionary studies involving animals or humans, and other studies require ethical approval  
 48 must list the authority that provided approval and the corresponding ethical approval code.

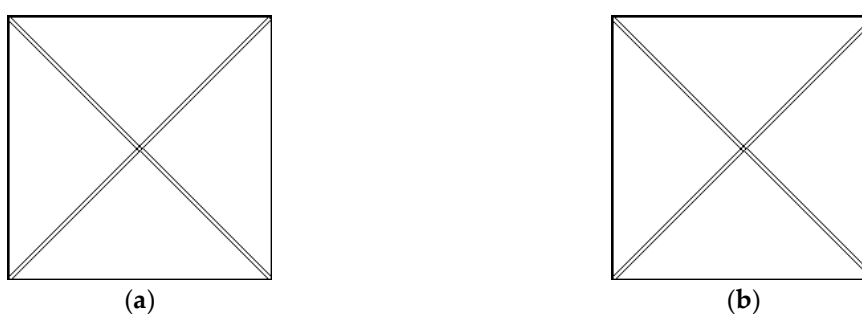

124 and duplicated references. Include the digital object identifier (DOI) for all references where available.
