### **Project title**

Proposition: Renew Eastern Partnership – the pearl of targeting EU's engagement for partners' needs and expectations (REAPPEAR)

### Project idea

Results of transformation and integration process within Eastern Partnership (EaP) countries have evidenced the need for renewal of the EU strategy. It should be focused on the specific problems of each country and the whole region, to reduce barriers, strengthen endogenous capacity of these countries in pursuit of the goals of the Eastern Partnership. Particular values should be more targeted and reinforce the EU's commitment to supporting the Eastern Partnership countries in gaining common goals appropriate to their needs and expectations. This requires an in depth diagnostic research, developing an effective mechanism for identifying and solving problems in a coordinated way.

We are a multidisciplinary team that represents political science, sociology and management, therefore we would like to participate in research project who's aim it would be to contribute to the development and implementation of the Eastern Partnership. This will increase the EU as a center of attraction by better adapting offers of cooperation which will meet the needs and expectations of the partners and increase the EU's accurately targeted involvement and more effective coordination of EU policy on the integration of the Eastern Partnership countries.

In particularly our research could focus on the following:

- in depth analysis of the progress made in achieving the aims of the EaP and relating existing bilateral relations with the EU and between the countries within the region, including geopolitical aspects such as the role of Russia and Turkey in the region;
- to identify critical factors who have impact on adaptation to the EU's standards (defining the specific needs and expectations of the partner countries to the EU; identifying factors attractive and repulsive partners, which of them have influence on increase confidence to the EU and can effectively stimulate political will of partners to reforms);
- to determine the political and social conditions necessary for the effective implementation of the Association Agreements.

We would like to concentrate on areas:

**From Better Capacities of Institutions to Better Policy Making** (diagnosis functioning of state institutions on diverse levels in the EaP countries, as well as bilateral, multilateral and EaP institutions for better shaping policies, decision- making processes, good governance for deeper democracy and civil society, more freedom, security and justice, as well as better policies on education, culture, youth and information society, People to People dimension.

**Peace in region** (analysis of cooperation in the framework of the CFSP/CSDP, especially in the context of enhancing the EU's role in resolving regional conflicts or differences).

**Development cooperation policy** (analysis towards better targeting and coordinating development assistance on EU and national levels).

The research results of our team consist of 170 thematic publications in four languages (Russian, English, Belarusian, Polish), including 7 books and 10 monographies edited and published in 5 countries. We have experience in qualitative and quantitative research, especially with regards to the Eastern Partnership countries, cross-border cooperation in Eastern Europe, Eastern dimension of the EU's and Poland's foreign policy, transformation in Eastern countries, migration, cooperation in the Baltic Sea Region, management and organizational culture. We also participate in every year research in field of Gdansk University of Technology Graduates Professional Situation.
